Of its 160 staff, 20 might be returning to the workplace in two groups of 10 - every group will work within the office on two or three days each week on alternate weeks. All returning employees should be totally vaccinated and must also take antigen fast tests earlier than coming into the workplace, mentioned Ms Barratt. 31-yr-previous civil servant Brandon's (not his actual name) office is still putting "testing measures" in place for the following eight weeks as they return to the workplace, he informed CNA. Before this, his management has been "largely supportive" in making certain they

have “as secure as possible” a transition again to work. This would come with versatile begin and finish instances, he stated. He was given three days every week to return to the office - but mentioned it was up to each division to decide how they wish to deploy the teams. “There is definitely that implicit understanding that we’d need to come back again on a few of these days for face-time, but personally, my very own bosses have left it fairly versatile for us,” he mentioned.
